Call to Order: President Jim Byerrum called the meeting to order at 10:07 a.m.

<u>President's Report:</u> President Byerrum stated that the purpose of establishing JPRIMA was to support CalMutuals and that performance of JPRIMA has exceeded expectations in terms of attracting membership and the timing of revenues.

<u>Insurance Administrator's Report:</u> Insurance Administrator Paul Fuller spoke about JPRIMA's partnership with Zenith Insurance Company and their workers compensation coverage and introduced Zenith Vice President, Chris Smith, who presented the Zenith online "Solutions Center."

Zenith/JPRIMA Solutions Center: Mr. Smith stated that Zenith is the second largest workers' compensation provider in California. The company's goal is to prevent accidents and injuries, and to assure the best medical care while containing costs and stopping fraud. Mr. Smith demonstrated the process of logging into a customized solutions center for water suppliers; the process for setting up a customized account and page; instructions for reaching Solutions Center

features including tools for safety training/tracking, management tools to track vendor certifications; how to grant employee permissions; and accessing signs, informational brochures, training materials and videos in English and Spanish.
