APPROVAL OF THE MINUTES OF THE JPRIMA BOARD MEETING ON OCTOBER

CONSIDERATION AND POSSIBLE APPROVAL OF DATE FOR ANNUAL

<u>MEMBERS' MEETING</u>: General Counsel Jim Ciampa provided an overview of the annual meeting requirements, as outlined in the bylaws. On a motion made by President Byerrum, seconded by Vice President Michalko, the annual members' meeting was scheduled for March 16, 2018 to be held at the Zenith Insurance Company headquarters in Woodland Hills. President Byerrum asked General Counsel Ciampa to review the Authority's bylaws to determine if any amendments are necessary in advance of the 2018 annual meeting.

<u>FINANCIAL REPORT</u>: President Byerrum provided an overview of the budget report. On a motion made by Vice President Michalko, seconded by Secretary Bradbury, the financial report was unanimously received and filed.

COMMUNICATIONS REPORT: Staff Member Ortega reported that he, along with President Byerrum, Director Armstrong, and Lynda Noriega, attended a workshop hosted by the State Water Resources Control Board and California Public Utilities Commission regarding mandatory consolidation and SB 623 (Monning). Staff Member Ortega added that he discussed JPRIMA's mission of providing technical assistance to small systems during the public comment period of the meeting.
